- 2) Dennis Wheeler asked about the guardrail on Brinker. Urbach reported the Stark County Engineers informed Urbach, that area does not warrant a guardrail. Wheeler asked why not. Urbach will get that information from the engineers.
- 3) Kurt and Ben Bravis expressed their displeasure in the consideration of a solar farm possibly going in on Beth. They were informed that the Board of Appeals is handling that. The Trustees have no decision on that. They need to go to a Board of Appeals meeting.
- 4) Glenn Haught stated he would like to see signs in the zoned area stating that area is zoned. Haught asked if there are new zoning books available? Matics stated that is the job of the Zoning Commission Board.

ROAD SUPERINTENDENT REPORT

- 1) Strubel ordered about 100 ton of salt that was delivered.
- 2) Strubel checked out the culvert on Student and it appears ok to him. It may be rusted on the bottom but it is not rusted through. You may want to get the County Engineers out there to check it out.
- 3) They have been working at the cemeteries cleaning them up.

ZONING INSPECTOR REPORT

- 1) Borojevich reported he is almost caught up with the backlog in zoning.
- 2) The Prosecutors have sent out letters to residents.
- 3) Borojevich has received five or six small violations he is working on.
