This permit is issued upon the following conditions and in compliance with Sec. 5571.16 and Sec. 5571.99 of the Ohio Revised Code. Effective August 15, 1955.

This permit pertains to one of the following:

- (a) Excavations within public R/W outside the berm and pavement.
  - (b) Opening of a dirt or gravel.
  - (c) Opening of an oil treated, chip and seal, black top or other type of hard road surface.
  - (d) Boring of the roads instead of open cuts.
- 1) Make all crossings of hard surfaced, black top or bituminous treated roads by boring or pushing and not by open cut, except by special permission.
- 2) The Applicant agrees to:
- (a) Properly tamp or puddle the backfill, or replace the backfill material, to the approval of the Township Road Supervisor.
  - (b) Clean out any ditches or culverts that may have been obstructed by the ditch operation.
  - (c) Clean the area and remove any excess debris back to the property line.
  - (d) Open Cut of an oil treated, chip and seal, Black top or other type of hard road surface applicant will replace the surface of the above-mentioned opening with 6" 304 Aggregate, 6" 301 Base

Asphalt and 1-1/4" Surface Asphalt. Applicant of this permit is responsible to any repairs needed to above-mentioned opening for one (1) year after date of acceptance of permit.

- (e) Opening of a dirt or gravel road, the road will be returned to the original state by the applicant of this permit. Applicant is responsible to any repairs needed to above-mentioned opening for one (1) year after date of acceptance of permit.
- 3) Before this permit is granted, it is required that the owner or Drain Layer will have secured the necessary: Sanitary \_\_\_\_\_ Water \_\_\_\_\_ Gas \_\_\_\_\_ connection permit from the proper authorities.
  - 4) The Contractor shall protect traffic at all times during the progress of the work and will use proper barricades, signs and lights so as to protect and provide safety for the general public.
  - 5) The Applicant and Contractor also agree to save Bethlehem Township and the Trustees free and harmless from any and all claims for damages to persons or property which might arise as a result of this work.
  - 6) It is further agreed that the Owner or Drain Layer will pay for extra work required to prepare the ditch openings if not left in satisfactory condition for the final surface treatment.
  - 7) Any Contractor failing to comply with the provisions of this permit will not be issued any further permits.
  - 8) The Owner or Contractor are subject to the penalty established in Sec. 5571.99 of the Ohio Revised Code providing they fail to comply with the conditions set forth in this permit.

If this application is approved and a permit is issued, the Applicant agrees to comply with all terms, conditions and restrictions as printed on this application. This permit may at any time be revoked or annulled by the Bethlehem Township Trustees for non-performance and /or non-compliance with any of the said conditions, restrictions and /or regulations. Violations of non-compliance of said regulations are subject to penalties as provided by Sec. 5591.26 of the Ohio Revised Code.
